 DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the **CATIGBIAN DISTRICT HOSPITAL, CATIGBIAN, BOHOL**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. - PHO – 2022 – 221 re: **PROCUREMENT OF LABORATORY SUPPLIES** with an ABC of **P 269,771.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BYRO PHARMA CORPORATION** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals,


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:




