WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 12-03-15-A series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by PROVINCIAL MOTOR POOL OFFICE in undertaking Procurement Request under PR No. 2022-0174 re; Procurement of Tires, by the Provincial Motor Pool, New Capitol Compound, Tagbilaran City. with an ABC of ₽ 513,750.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation:
