WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0111 re; Procurement of Van Rental, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of P 100,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL TOURIST MULTI-PURPOSE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
