RESOLUTION NO. 22-1195 Series of 2022

WHEREAS, the <u>PROVINCIAL GENERAL SERVICES OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. 2022-C-146 re: <u>PROVISION OF CATERING SERVICES DURING THE PGSO FORUM FOR ADMIN OFFICERS AND SUPPLY OFFICER OF PGBH OFFICES AND DEVOLVE HOSPITALS</u> with an ABC of P 70,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PANDA TEA GARDEN</u> SUITES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

- b). To recommend award to <u>PANDA TEA GARDEN SUITES</u> for the Catering Services of the aforementioned request in the amount of <u>P 69, 800.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
