WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. <u>22-0365-A</u> series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the <u>PROVINCIAL HEALTH OFFICE</u> in undertaking Procurement Request under PR No.2022-C-137 re: <u>PROCUREMENT OF CATERING SERVICES DURING THE NATIONAL PREVENTION OF BLINDESS PROGRAM</u> with an ABC of <u>P 299,850.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of showed that <u>PANDA TEA GARDEN</u>
