BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0634 series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **PROVINCIAL GENERAL SERVICES OFFICE, NEW CAPITOL BUILDING TAGBILARAN CITY** in undertaking Procurement Request under PR No. 2022-0288, re: Procurement of Brand New Vehicle with an ABC of ₱1,200,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **FAST AUTOWORLD PHILIPPINES CORPORATION** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;
