WHEREAS, the PROVINCIAL VETERINARIAN OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0257 re; Procurement for Vehicle Rental as Transportation Service During the Conduct of Activities in Support to African Swine Fever (ASF), by the Provincial Veterinarian Office, New Capitol Building Cogon District, Tagbilaran City. with an ABC of P 135,000.00;
