BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the PROVINCIAL VETERINARIAN OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0257 re; Procurement for Vehicle Rental as Transportation Service During the Conduct of Activities in Support to African Swine Fever (ASF), by the Provincial Veterinarian Office, New Capitol Building Cogon District, Tagbilaran City, with an ABC of P 135,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL TOURIST MULTI-PURPOSE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
