BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the PROVINCIAL ENGINEER'S OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0900 re; Procurement of Anapog for Repair & Regraveling of Barangay Baunos, San Isidro Circumferential Road, by the Provincial Engineer's Office, Bohol Provincial Capitol, Cogon District, Tagbilaran City, Bohol. with an ABC of P 618,750.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CLAVITE CONSTRUCTION & SUPPLY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
