

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

RESOLUTION NO. 22-0849 Series of 2022

WHEREAS, the <u>BOHOL DISTRICT JAIL</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2021-0641</u> re; <u>Procurement of Floor Mounted Air Conditioning Unit & Chest Type Freezer, by the Bohol District Jail, Cabawan District, Tagbilaran City.</u> with an ABC of <u>P 178,000.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>SAMMY'S</u> <u>AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>SAMMY'S AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation <u>SAMMY'S AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>SAMMY'S AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP</u> as the supplier with the <u>LOWEST CALCULATED AND RESPONSIVE QUOTATION</u> for the <u>DELIVERY OF GOODS/SERVICES</u> under Negotiated Canvass No. <u>2021-0422</u>;
- b.) To recommend award to <u>SAMMY'S AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP</u> for the delivery of goods/services under Negotiated Canvass No. <u>2021-0422</u> in the amount of <u>P 177,754.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
