BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the BOHOL DISTRICT JAIL, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2021-0641 re: Procurement of Floor Mounted Air Conditioning Unit & Chest Type Freezer, by the Bohol District Jail, Cabawan District, Tagbilaran City. with an ABC of P 178,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that SAMMY'S AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

- b.) To recommend award to SAMMY'S AIRCONDITIONING & REFRIGERATION SERVICES & REPAIR SHOP for the delivery of goods/services under Negotiated Canvass No. 2021-0422 in the amount of P 177,754.00;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
