BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **GOVERNOR'S OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0508 re; Procurement of Ceiling Panel Light for the use at the Office of the Governor, New Capitol Compound, Tagbilaran City. with an ABC of P 167,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PRIM E CONSTRUCTION SUPPLIES TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **PRIM E CONSTRUCTION SUPPLIES TRADING** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **PRIM E CONSTRUCTION SUPPLIES TRADING** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;
