BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the PADMO-PROVINCIAL PROCUREMENT MANAGEMENT UNIT, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0598re; Procurement of various Office Supplies, by the Provincial Procurement Management Unit, New Capitol Building, Cogon District, Tagbilaran City with an ABC of P 103,800.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION SUPPLIES TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of PRIM E CONSTRUCTION SUPPLIES TRADING, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation PRIM E CONSTRUCTION SUPPLIES TRADING has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

- b.) To recommend award to PRIM E CONSTRUCTION SUPPLIES TRADING for the delivery of goods/services under Negotiated Canvass No. 2022-0426 in the amount of P 103,744.80;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
