

BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the <u>PADMO-PROVINCIAL PROCUREMENT MANAGEMENT UNIT</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022-0598re</u>; <u>Procurement of various Office Supplies</u>, <u>by the Provincial Procurement Management Unit</u>, New Capitol Building, Cogon District, Tagbilaran City with an ABC of P 103,800.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PRIM E CONSTRUCTION SUPPLIES</u> <u>TRADING</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **PRIM E CONSTRUCTION SUPPLIES TRADING** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation **PRIM E CONSTRUCTION SUPPLIES TRADING** has been found to be ELIGIBLE and its bid, RESPONSIVE;
