BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the <u>PROVINCIAL ACCOUNTING OFFICE</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022-0362</u> re; <u>Procurement of Various Offices Supplies, AAA & AA Batteries and Heavy Duty Automatic Numbering Machine</u>, by the <u>Provincial Accounting Office</u>, New Capitol Compound, <u>Tagbilaran City</u>. with an ABC of <u>P 87,622.50</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <a href="PRIM E CONSTRUCTION SUPPLIES">PRIM E CONSTRUCTION SUPPLIES</a>
TRADING offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <a href="PRIME">PRIME</a> CONSTRUCTION SUPPLIES TRADING including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation <a href="PRIME">PRIME</a> CONSTRUCTION SUPPLIES TRADING has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare PRIM E CONSTRUCTION SUPPLIES TRADING as the supplier with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. 2022-0253
- b.) To recommend award to <u>PRIM E CONSTRUCTION SUPPLIES TRADING</u> for the delivery of goods/services under Negotiated Canvass No. <u>2022-0253</u> in the amount of <u>P 87,502.85</u>;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
