**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE,  
DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the **PROVINCIAL HEALTH OFFICE, NEW CAPITOL SITE COGON DISTRICT, TAGBILARAN CITY, BOHOL**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under **Purchase Requests No. - PHO - 2022 - 152** re: **PROCUREMENT OF HP LASERJET TONER AND DRUM KIT** with an ABC of **P 97,700.00**;






NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:






