BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the PROVINCIAL MOTOR POOL OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0437 re; Procurement of Diesel Fuel for the motor vehicle, Assigned under the Provincial Motor Pool Office, New Capitol Compound, Tagbilaran City, with an ABC of P 182,750.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE has been found to be ELIGIBLE and its bid, RESPONSIVE;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




