BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the <u>PROVINCIAL MOTOR POOL OFFICE</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022-0437</u> re; <u>Procurement of Diesel Fuel for the motor vehicle</u>, <u>Assigned under the Provincial Motor Pool Office</u>, <u>New Capitol Compound</u>, <u>Tagbilaran City</u>, with an ABC of <u>P 182,750.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL PROVINCIAL EMPLOYEES</u> <u>MULTI-PURPOSE COOPERATIVE_offered</u> the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation <u>BOHOL PROVINCIAL EMPLOYEES MULTI-PURPOSE COOPERATIVE</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:
