BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the <u>BOHOL INVESTMENT PROMOTION CENTER</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022-0149</u> re; <u>Procurement of Various Office Supplies</u>, by the Bohol Investment Promotion Center, Bohol <u>Provincial Capitol Building</u>, <u>Tagbilaran City</u>, <u>Bohol.</u>, with an ABC of <u>P 100,728.53</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PRIM E CONSTRUCTION SUPPLIES
TRADING
offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>PRIM E CONSTRUCTION SUPPLIES TRADING</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation <u>PRIM E CONSTRUCTION SUPPLIES TRADING</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to <u>PRIM E CONSTRUCTION SUPPLIES TRADING</u> for the delivery of goods/services under Negotiated Canvass No. <u>2022-0088</u> in the amount of <u>P 100,672.85</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
