BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the PROVINCIAL PLANNING & DEVELOPMENT OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0530 re; Provision for the Vehicle Rental, by the Provincial Planning & Development Office, New Capitol Building, Tagbilaran City, with an ABC of P 97,300.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL TOURIST MULTI-PURPOSE COOPERATIVE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of BOHOL TOURIST MULTI-PURPOSE COOPERATIVE including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation BOHOL TOURIST MULTI-PURPOSE COOPERATIVE has been found to be ELIGIBLE and its bid, RESPONSIVE;

- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.


