BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the <u>PROVINCIAL PLANNING & DEVELOPMENT OFFICE</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022-0530</u> re; <u>Provision for the Vehicle Rental, by the Provincial Planning & Development Office, New Capitol Building</u>, Tagbilaran City, with an ABC of P 97,300.00.

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>BOHOL TOURIST MULTI-PURPOSE</u> <u>COOPERATIVE</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BOHOL TOURIST MULTI-PURPOSE COOPERATIVE</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation <u>BOHOL TOURIST MULTI-PURPOSE COOPERATIVE</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>BOHOL TOURIST MULTI-PURPOSE COOPERATIVE</u> as the supplier with the **LOWEST CALCULATED AND** RESPONSIVE QUOTATION for the <u>DELIVERY OF GOODS/SERVICES</u> under Negotiated Canvass No. <u>2022-0382</u>;
- b.) To recommend award to <u>BOHOL TOURIST MULTI-PURPOSE COOPERATIVE</u> for the delivery of goods/services under Negotiated Canvass No. <u>2022-0382</u> in the amount of <u>P 97,300.00</u>;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
