BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the <u>PROVINCIAL MOTOR POOL OFFICE</u>, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022-0223</u>re; <u>Procurement of Oil and Lubricants, Assigned under the Provincial Motor Pool Office, New Capitol Compound, Tagbilaran City.</u> with an ABC of <u>P 873,500.00.</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that NORTHWAY TYRE CENTRE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
