WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-049 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE PROVINCIAL AGRICULTURIST in undertaking Procurement Request under PR No. 2022-0124 re; Procurement of Organic Fertilizer/Vermicast/Vermicompost, Animal Manure & Hauling Soil Media, by the Office of the Provincial Agriculturist, New Capitol Compound, Tagbilaran City. with an ABC of P1,232,400.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>LEZAR TRADING</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, LEZAR TRADING has been found to be ELIGIBLE and its quotation, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare <u>LEZAR TRADING</u> as the supplier with the <u>Lowest Calculated</u> and <u>Responsive Price Quotation</u> for the Delivery of <u>Goods/Services</u> under Negotiated Canvass No. <u>2022-0264</u> (2ND <u>Failure</u>);
- b). To recommend award to <u>LEZAR TRADING</u> or delivery of goods/services under Negotiated Canvass No. <u>2022-0264</u> (<u>2nd Failure</u>) in the amount of <u>P 1,230,338.75</u>;
- c) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
