WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. <u>22-0251</u> series of 2021 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the <u>OFFICE OF THE PROVINCIAL AGRICULTURIST</u> in undertaking Procurement Request under PR No.2022-C-059 re: <u>PROCUREMENT OF CATERING SERVICES FOR THE DIFFERENT ACTIVITIES FOR PLANNING AND MONITORING DIVISION FOR THE 3RD QUARTER OF 2022 with an ABC of <u>P 108, 750.00</u>;</u>

WHEREAS, canvass of prices done in the course of the Negotiated Method of showed that <u>REYNA'S THE HAVEN</u>
