BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

WHEREAS, the <u>PROVINCIAL ECONOMIC ENTERPRISE MANAGEMENT OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2020-0209</u>; re; <u>Procurement of Various Furnitures for the use at the Provincial Economic Enterprise Management Office, New Capitol Site, Tagbilaran City.</u> with an ABC of <u>P 96,180.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>D\_18TH HI-WAY</u> <u>MARKETING</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>D 18TH HI-WAY MARKETING</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>D 18TH HI-WAY MARKETING</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
