WHEREAS, the OFFICE OF THE VICE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0518 re; Supply and Installation of Glass Door Partition for the use at the Office of the Vice Governor, New Capitol Building, Tagbilaran City. with an ABC of P 123,590.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BQ BUILDERWARE offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


