**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING
LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

BIDS AND AWARDS COMMITTEE

WHEREAS, the **BOHOL EMPLOYMENT & PLACEMENT OFFICE**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. **2022-0515**, re: **Procurement of Blinds Color Blue for use at the Bohol Employment & Placement Office - Public Employment Service Office, New Capitol Building, Tagbilaran City**, with an ABC of **P 38,771.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **BOHOL INTERIOR BLINDS CENTER** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
