WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0693 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **BOHOL MINERAL RESOURCES REGULATORY OFFICE** in undertaking Procurement Request under PR No. 2022-0330; Procurement of Handheld GPS Navigator for use at the Bohol Mineral Resources Regulatory Office (BMinRRO), New Capitol Building, Tagbilaran City. with an ABC of **₱ 50,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **B AND J COMPUTER SALES AND ELECTRONIC SERVICES INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:


