BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the BOHOL PROVINCIAL TOURISM OFFICE, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0516 re; Procurement of Diesel Fuel, by the Bohol Tourism Office, Bohol Provincial Capitol Building, Tagbilaran City, with an ABC of P 52,200.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL JL DISTRIBUTION SYSTEM INC., offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
