BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-264 re: PROCUREMENT OF MEALS AND SNACKS FOR THE DEVELOPMENTAL AND CONSULTATIVE MEETINGS INCLUDING COURTESY VISITS WITH VARIOUS STAKEHOLDERS, SECTORAL GROUPS, PRIVATE SECTOR, CIVIL SOCIETY ORGANIZATION AND OTHER GOVERNMENT PARTNERS with an ABC of P 656, 250.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

WHEREAS, pursuant to Section 53.9 of the Implementing Rules and Regulations of RA 9184, upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>REYNA'S THE HAVEN AND GARDENS</u> <u>FOOD CATERING SERVICES, INC.</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>REYNA'S THE HAVEN AND GARDENS FOOD CATERING SERVICES, INC.</u> has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:
