## **BAC Resolution Declaring LCRQ and Recommending Award**

WHEREAS, the GOVERNOR'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-339 re: PROCUREMENT OF MEALS AND SNACKS FOR THE GOVERNOR'S OFFICE and PADMO EMPLOYEES DURING THE FAMILY DAY 2022 with an ABC of P 199,500.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>REYNA'S THE HAVEN</u> <u>AND GARDENS FOOD CATERING SERVICES, INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
