BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE MODE OF THROUGH DIRECT CONTRACTING, DECLARING SOLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL
