BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARATORY BIDDING, CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **OFFICE OF THE GOVERNOR – ADMIN, SPECIAL EVENTS AND GENERAL SERVICES SECTIONS, BUILDING, TAGBILARAN CITY** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requisition No. **2022-0632** re: **Purchase of Floor Tiles, Liquid Concrete Epoxy, Tile Grout, Baby Roller, and Paint Brush** with an ABC of **P 118,020**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PRIM E CONSTRUCTION SUPPLIES TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation documents of **PRIM E CONSTRUCTION SUPPLIES TRADING** including the price quotation offered, to determine its eligibility to be **ELIGIBLE** and its bid, **RESPONSIVE**;
