BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the OFFICE OF THE GOVERNOR, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0579, re; Provision of Transport Rental for visiting dignitaries by the Office of the Governor, New Capitol Building, Tagbilaran City, with an ABC of P 290,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PAMILACAN ISLAND DOLPHIN AND WHALE WATCHING TOURS offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of PAMILACAN ISLAND DOLPHIN AND WHALE WATCHING TOURS, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation PAMILACAN ISLAND DOLPHIN AND WHALE WATCHING TOURS has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:




