BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the <u>CATIGBIAN DISTRICT HOSPITAL</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. <u>2022-0049</u> re; <u>Repair of Roofing, Replacement of Dilapidated Roof Gutters and Brooken Floor Tiles at Catigbian District Hospital.</u> with an ABC of P 335,719.06;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>3N CONSTRUCTION</u> <u>& SUPPLY</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>3N CONSTRUCTION & SUPPLY</u> including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid <u>3N CONSTRUCTION & SUPPLY</u> has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>3N CONSTRUCTION & SUPPLY</u> as the bidder with the LOWEST CALCULATED AND RESPONSIVE BID for the DELIVERY OF GOODS/SERVICES under Negotiated Canvass No. <u>2022-0012</u>;
- b.) To recommend award to <u>3N CONSTRUCTION & SUPPLY</u> for the delivery of goods/services under Negotiated Canvass No. <u>2022-0012</u> in the amount of <u>P 334,705.00</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
