BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-297** re: PROVISION OF CATERING SERVICES FOR THE DIFFERENT ACTIVITIES OF THE CROPS UNIT DIVISION/ RICE UNIT with an ABC of **₱ 67, 000.00**;
