**BAC Resolution Declaring SCRQ through Negotiated Mode of Procurement – Emergency Cases
and Recommending Award**

WHEREAS, the PROVINCIAL VETERINARIAN'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-284 re: PROCUREMENT OF CATERING SERVICES FOR THE BANTAY BAYAN SA BARANGAY COSNULTATIVE MEETINGS with an ABC of ₱ 375, 000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that PANDA TEA GARDEN SUITES offered the single price quotation as reflected in the Abstract of Bids Proposals;
