WHEREAS, the **PROVINCIAL VETERINARIAN'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-330** re: **PROCUREMENT OF ACCOMMODATION AND CATERING SERVICES FOR THE TRAINER'S TRAINING ON MEAT PROCESSING** with an ABC of **₱ 67,000.00**;
