BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the <u>PROVINCIAL VETERINARIAN'S OFFICE</u> of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-330 re: <u>PROCUREMENT OF ACCOMMODATION AND CATERING SERVICES FOR THE TRAINER'S TRAINING ON MEAT PROCESSING</u> with an ABC of <u>P 67,000.00</u>;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>PANDA TEA GARDEN</u> <u>SUITES</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
