BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE MODE OF PROCUREMENT THROUGH DIRECT CONTRACTING, DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. 2022 – 0426 re: Procurement of Toner Kit Black, Kyocera TK-6329 with an ABC of P 61,160.00;

WHEREAS, above requisitioned goods are sold/distributed/provided by PHILCOPY CORPORATION, sole distributor of the aforementioned brand of products;
