BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE MODE OF PROCUREMENT THROUGH DIRECT CONTRACTING, DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the **OFFICE OF THE PROVINCIAL VETERINARIAN**, of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of the goods under Purchase Request No. **2022 – 0426**, re: **Procurement of Toner Kit Black, Kyocera TK-6329**, with an ABC of **P 61,160.00**;

WHEREAS, above requisitioned goods are sold/distributed/provided by **PHILCOPY CORPORATION**, sole distributor of the aforementioned brand of products;

- b) To declare **PHILCOPY CORPORATION**, as the sole distributor of said products in the amount of **P 61,160.00** under Direct Contracting Canvass No. **2022-0020**; thus, recommendation for award is hereby conferred to;
- c) To recommend approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
