**WHEREAS**, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0998 series of 2022 re: BAC Resolution Declaring 2<sup>nd</sup> Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by **OFFICE OF THE PROVINCIAL VETERINARIAN** in undertaking Procurement Request under PR No. **2022-0379**; Procurement of various MEAT Processing Ingredients for use in training cum production, by the Office of the Provincial Veterinarian, New Capitol Building, Tagbilaran, City, Bohol. with an ABC of ₱ 126,565.00;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that **PRIM E CONSTRUCTION SUPPLIES TRADING** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;



**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:






