BAC RESOLUTION RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 22-0656 series of 2022 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by OFFICE OF THE PROVINCIAL VETERINARIAN, NEW CAPITOL BUILDING, TAGBILARAN CITY in undertaking Procurement Request under PR No. 2022-0340 re; Procurement of DIESEL with an ABC of P 313,950.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL JL DISTRIBUTION SYSTEM INC., offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotation;




NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:


