BAC Resolution Recommending Procurement thru Negotiated Mode under Lease of Property and Venue, Declaring Lowest Calculated and Responsive Quotation and Recommending Award

WHEREAS, the **PROVINCIAL ASSESSOR'S OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2022-C-312** re: **PROVISION OF MEALS, SNACKS AND HOTEL ACCOMMODATION FOR THE PASSO PERSONNEL DURING THE MID-YEAR ASSESSMENT AND OPERATIONAL PLANNING WORKSHOP** with an ABC of **₱ 200,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement thru Lease of Property and Venue showed that **SOUTH PALMS RESORT PANGLAO** offered the lowest price quotations among the suppliers as reflected in the Abstract of Bids Proposals;
