BAC RESOLUTION DECLARING LOWEST COMPLYING AND RESPONSIVE BID AND RECOMMENDING APPROVAL

WHEREAS, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the Newspaper, PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

WHEREAS, after the opening of bids, the following are the result of the bid proposals of the bidders to wit:

WHEREAS, in the detailed evaluation of bids, tie between **GOLDEN AI TRADING** and **SANDUGO PRESS MARKETING & SUPPLIES** quoted for item nos. 12, 19, 20, 21 and 27 and a toss coin was recommended. After the toss coin has been done, item nos. 19 and 20 prevails for **GOLDEN AI TRADING** while item nos. 12, 21 and 27 for **SANDUGO PRESS MARKETING & SUPPLIES**. **GOLDEN AI TRADING** for item nos. 2, 14, 17, 19, 20, 22, 23, 25 and 28 while **SANDUGO PRESS MARKETING & SUPPLIES** for item nos. 4-12, 15, 16, 21, 24, 26, and 27 AND **BOHOL QUALITY CORPORATION** for item nos. 3, 13, and 18. For item no. 1 is recommended for Petty Cash Purchase;

WHEREAS, upon the conduct of post qualification by the Technical Working Group, **GOLDEN AI TRADING, SANDUGO PRESS MARKETING & SUPPLIES AND BOHOL QUALITY CORPORATION** met the required legal, technical and financial requirements for the said project;


WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **GOLDEN AI TRADING, SANDUGO PRESS MARKETING & SUPPLIES AND BOHOL QUALITY CORPORATION**, the bidders declared as the **LOWEST CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **LOWEST COMPLYING and RESPONSIVE BID** for the said project;


NOW THEREFORE, We the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:


- a) To declare **GOLDEN AI TRADING** was declared as the Lowest Calculated Bid as Read for item nos. **2, 14, 17, 19, 20, 22, 23, 25 and 28**, while **SANDUGO PRESS MARKETING & SUPPLIES** was declared as the Lowest Calculated Bid as Read for item nos. **4-12, 15, 16, 21, 24, 26, and 27** AND **BOHOL QUALITY CORPORATION** was declared as the Lowest Calculated Bid as Read for item nos. **3, 13, and 18** for the PROCUREMENT OF VARIOUS OFFICE SUPPLIES;
- b) To recommend award to **GOLDEN AI TRADING** was declared as the Lowest Calculated Bid as Read for item nos. **2, 14, 17, 19, 20, 22, 23, 25 and 28**, in the amount of **P 30,099.00** while **SANDUGO PRESS MARKETING & SUPPLIES** was declared as the Lowest Calculated Bid as Read for item nos. **4-12, 15, 16, 21, 24, 26, and 27** in the amount of **P 73,000.00** AND **BOHOL QUALITY CORPORATION** was declared as the Lowest Calculated Bid as Read for item nos. nos. **3, 13, and 18** in the amount of **P 3,358.00** and for item no. **1** is recommended for Petty Cash Purchase for the PROCUREMENT OF VARIOUS OFFICE SUPPLIES;
- c) To recommend for the approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.




