BAC RECOMMENDING PROCUREMENT THRU NEGOTIATED METHOD RESULTING FROM THE SECOND FAILURE OF BIDDING, DECLARING LCRQ AND RECOMMENDING AWARD

WHEREAS, the BIDS AND AWARDS COMMITTEE passed BAC Resolution No. 20-437 series of 2020 re: BAC Resolution Declaring 2nd Failure of Bidding and Recommending Procurement through Negotiated Mode; and was duly approved by the Honorable Governor, authorizing the use of the such Method of Procurement by the CATIGBIAN DISTRICT HOSPITAL in undertaking Procurement Request under PR No. 2020-0894 re: CONSTRUCTION OF SEWAGE TREATMENT FACILITY WITH BIOLOGICAL AND NUTRIENT REMOVAL AT CATIGBIAN DISTRICT HOSPITAL, CATIGBIAN, BOHOL with an ABC of ₱ 5,661,570.94;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that 3N CONSTRUCTION AND SUPPLY offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals;

WHEREAS, upon careful examination, validation and verification of the accreditation and other pertinent documents, including the price quotation offered, to determine its eligibility to transact business with the provincial government and the responsiveness of its bid and as provided for under paragraph a of Section 53.1 of the Implementing Rules and Regulations of R.A. 9184, 3N CONSTRUCTION AND SUPPLY has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVES, as it is hereby RESOLVED:

- a). To declare 3N CONSTRUCTION AND SUPPLY as the supplier with the Lowest and Responsive Price Quotation for the Delivery of Goods/Services under Negotiated Canvass No. NC-2021-005(2nd Failure);
- b). To recommend award to 3N CONSTRUCTION AND SUPPLY for delivery of goods/services under Negotiated Canvass No. NC-2021-005(2nd Failure) in the amount of ₱ 5,660,046.83;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
