**WHEREAS**, the PROVINCIAL ENGINEER'S OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2022-0477 re; Procurement of Fuel for the Equipment, by the Provincial Engineer's Office, New Capitol Building, Cogon District, Tagbilaran City. with an ABC of P 249,975.00;

**WHEREAS**, canvass of prices done in the course of the Negotiated Method of Procurement showed that BOHOL JL DISTRIBUTION SYSTEM, INC. offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;
