BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL HEALTH OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2022-C-384 re: PROCUREMENT OF MEALS AND SNACKS FOR THE ORIENTATION OF LOCAL CHIEF EXECUTIVES, CITY/ MUNICIPAL HEALTH OFFICE ON INTEGRATION POLICIES RELATED TO UNIVERSAL HEALTH CARE with an ABC of ₱ 96,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that PANDA TEA GARDEN SUITES offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
