
WHEREAS, the above Procurement Request was presented to the BIDS AND AWARDS COMMITTEE for deliberation and proper action;


~~NOW, THEREFORE~~ We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- c) To recommend approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings






