BAC RESOLUTION DECLARING SCRQ THROUGH NEGOTIATED MODE OF PAYMENT – EMERGENCY CASES AND RECOMMENDING AWARD –

WHEREAS, the CANDIJAY COMMUNITY HOSPITAL, CANDIJAY, BOHOL of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **PHO – 2022 – 216 re: Procurement of X-ray Supplies** with an ABC of **₱ 104,800.00;**

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that BYRO PHARMA CORPORATION & PRECIOUS PRINCE ENTERPRISES offered the single price quotation as reflected in the Abstract of Bids Proposals;
